





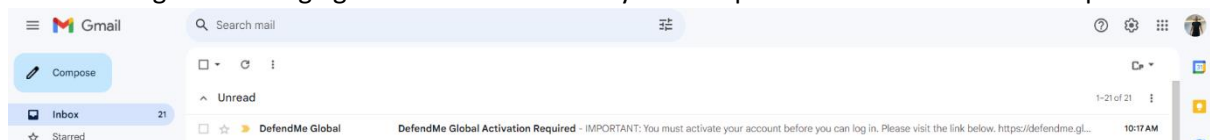

Step 3:

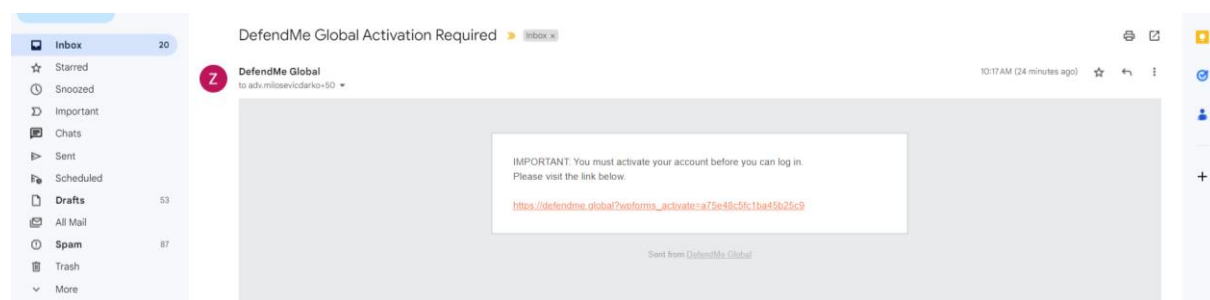
After finishing the previous step you will receive this message.
